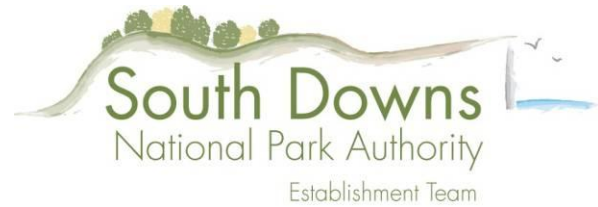

### Update on Appointment of Authority Members

On 10 December, Hilary Benn announced that the Park Authority would have 27 Members comprising:

- 14 Councillors from the Local Authorities covering the Park (listed with their nominating Local Authority in the table below)
- 6 Parish Councillors from within the Park (listed as 'PC' in the table below)
- 7 national Members appointed by the Secretary of State through an open recruitment process (listed as 'Sec. Of State' in the table below)

25 Members have been appointed so far. The remaining 2 Local Authority nominations will be confirmed during March. The Authority Members will take strategic decisions for the National Park and ensure the Authority responds to the aspirations of the people who live in, work in & visit the Park.

### South Downs National Park Anticipated Timeline

#### ~February/March 2010

The names of the Park Authority members are announced.

#### ~March 2010

A Statutory Instrument is laid in Parliament enabling the establishment of the Park Authority.

Members training programme begins.

#### ~31 March 2010

The South Downs National Park designation takes effect. The two AONB designations are revoked.

#### ~April 2010

The South Downs National Park Authority meets for the first time. The Chair of the Authority is elected by the Members.

The Authority begins to make strategic decisions as it prepares to become fully operational in 2011.

#### ~March 2011

The South Downs Joint Committee winds up.

#### ~April 2011

The South Downs National Park Authority takes on its statutory planning responsibilities and becomes fully operational.

The Team members were struck by the enthusiasm showed by the Volunteer Rangers and their wish to be associated with the National Park Authority in to the future.

All the comments and feedback from the Volunteer Rangers will be used to inform the new NPA Members as they take decisions about the Authority's work and role.

Around 420 Volunteer Rangers currently work with the South Downs Joint Committee and some have been helping to look after the South Downs for over 20 years. The volunteers undertake a wide range of tasks including practical conservation work, Rights of Way monitoring and maintenance, Dutch Elm Disease monitoring and guided walks.

### ***Where can I find out more about the Park Authority and what is happening?***

### ***Where will the HQ be located?***

We want to hear your views on this. A short questionnaire will be on the Park Authority website from 9<sup>th</sup> March. Please go to [www.southdowns.gov.uk](http://www.southdowns.gov.uk) consultations and take a few moments to answer the ten questions. We will use the results to inform our search for premises in the summer and autumn.

### ***We have heard a lot about Rights of Way recently, how will this work in the future?***

The SDNP Authority is an Access Authority – which means it will become responsible for Open Access across the South Downs (CRoW Act). It must also establish an advisory group known as the Local Access Forum. However, the Authority is not responsible for rights of way. This is still the role of the Highways Authorities – County Councils and Unitary Authorities.

The challenge across the South Downs is to ensure high quality and consistency of provision across the Rights of Way network. The Authority will need to find the best way of working in partnership with other agencies to ensure this is delivered for local users and visitors.

### ***Do you know what the budget will be for the National Park Authority?***

In short, no, we have not yet been advised of the budget for 2010/11, but expect to hear in the next month. The Park Authority will be fully funded by national Government through Defra.
